


Registration Process

1. Visit the SLRMUN Registration portal through the link mentioned below.

2. You will be redirected to the registration page. Fill in the registration details carefully and click “REGISTER”.



4. You will see a **RED** color “**COMMITTEE REGISTRATION STATUS**” Banner. This will be updated with your real time registration status.




Figure 3 : "COMMITTEE REGISTRATION STATUS" Banner




Figure 4 : Updated "COMMITTEE REGISTRATION STATUS" Banner

7. Then go the “**Committee Selection**” section through the side panel.




Figure 5 (a): “Committee Selection” section in side panel





Figure 5 (b): “Committee Selection” section

9. After arranging the committees according to your preference, click the “**SAVE**” button to save your preference list. This preference list will be used to allocate a committee for you.





12. This will also update the “**COMMITTEE REGISTRATION STATUS**” Banner as given below. And below that you may find your reservation details. (You will no longer be able to change your committee preference order.)




Figure 8: Updated Committee Registration Status

2. You are not required to submit a Foreign Policy Statement for SLRMUN 24. So, you can ignore “**FPS Submission**” section.
3. Use **LOGIN** button instead of **REGISTER** button when you are logging in to your account after the first time.
